



SRI LANKA LAW COLLEGE NOTICE

Scholarship Scheme for Internal Students

The following proposed scholarship scheme has been approved by the Council of Legal Education for the financially affected students.

A. Required Documents:

1. Completed Application Form (See Annexure A)
2. Applicant's Affidavit stating the need for financial support.
3. Affidavit/Letter from the Grama Niladari confirming the financial status of the applicant.
4. Two affidavits/letters from a non-related referee confirming the financial status of the applicant.
5. Any additional supporting documentation.
6. Police Character Certificate.

B. Selection Criteria:

1. Direct Entry Students: Must be Sri Lanka Law College direct entry students selected through the general entrance examination.
2. Age Limit: Applicants should be below 30 years of age.
3. Financial Need: Demonstrated financial need is the key criterion for selection.
4. Academic Excellence: Consideration will be given to academic achievements, with different criteria for preliminary and intermediate-year students.
 - Preliminary Year: GCE A/L results and merit of the General Entrance examination.
 - Intermediate Year: Performance in Attorneys at Law First Year examination.
 - Failed or referred students cannot apply for the scholarship.
5. Extra-Curricular Activities: Active involvement in extracurricular activities within the Law College or related fields is considered.

C. Financial Assistance:

1. The students' fees for the respective years are as follows:
 - a. Preliminary Year – LKR 87,500
 - b. Intermediate Year – LKR 58,000
 - c. Final Year – LKR 75,500

2. The selected students will be given a scholarship of 50% of their annual fees (above listed fees).
3. However, full examination fees must be paid separately at the time of calling for the examination payment registration.
4. No exemption will be given to the students on examination fees.
5. The scholarship fee structure:
 - a. Preliminary Year – LKR 23,750 to be paid on the date of registration and LKR 20,000 to be paid at the time of applying for the Preliminary Year Examination.
 - b. Intermediate Year – LKR 29,000 to be paid on the date of registration and LKR 17,500 to be paid at the time of applying for the Intermediate Year Examination.

D. Submission of Application and other relevant documents

1. For intermediate year students: **January 19, 2024.**
2. For preliminary year students: **February 09, 2024.**

E. Important Notes:

1. The selection will be made by a committee appointed by the Incorporated Council of Legal Education.
2. Applicants may be required to undergo an interview during the selection process.
3. Students withdrawing from the relevant Attorneys at Law October examination cannot apply for the scholarship.
4. Students submitting a medical withdrawal from the relevant Attorneys at Law October examination can apply for the scholarship with the approval of the Principal. However, failure to complete the examination in the next April session will lead to the automatic cancellation of the scholarship, with the remaining payment to be settled.
5. This scholarship is only valid for one year. Students need to reapply for the following year.

Please note:

- This notice does not apply to Final Year students in the 2024 Academic Year.
- Since the results of the October 2023 Attorneys at Law examinations are pending, Intermediate students (for the academic year 2024) can apply by mentioning 'results are pending' in No. 11 of the Scholarship Application Form.
- Incomplete, Illegible, or Unqualified applications will be rejected without notice.
